## McNees' Kelley E. Kaufman Selected for YWCA of Greater Harrisburg Women of Excellence Award Winner



HARRISBURG, PA – McNees Wallace & Nurick member Kelley E. Kaufman was selected as a YWCA Tribute to Women of Excellence 2017 award recipient. It is the 28th year the YWCA of Greater Harrisburg has hosted the Tribute to Women of Excellence event.

Kaufman will be presented the award at a celebration dinner on Thursday, March 23 at the Hershey Lodge. Since its inception, the Tribute to Women of Excellence awards ceremony has honored more than 550 women for their

contributions to the workplace and community and has raised hundreds of thousands of dollars in support of YWCA programs for women, children, and men.

"Leading by example in supporting the advancement of women in both law and work in the community, Kelley is a first-class lawyer with an exceptional track record of achieving excellent results for our clients," McNees Chairman David Kleppinger said. "We are very pleased that Kelley is the recipient of this well-deserved honor."

This year's race in Harrisburg attracted 300 participants and it was followed by a Humanity Festival featuring culturally diverse entertainers, food, vendors and fun activities for children of all ages.

In addition, Kaufman is a member of the Historical Society of Dauphin County, where she served on the Board of Trustees from 2011 to 2014 and on the Personnel Committee in 2014 and 2015. Since 2015, she has also volunteered as a Committee member for the burgeoning Capital Area Girls on the Run, which seeks to empower school-aged girls through distance running, working as a mentor to teach young girls to be joyful, healthy, and confident.

Additionally, Kaufman is a member of the United Way Women's Leadership Network where she is further committed to the welfare of women and children in the region. She is also a member of the Junior League of Harrisburg, and served as the Done-in-a-Day Projects Committee Chair, the Grants Committee Chair, the Meetings/Social Committee Chair, and as a Parliamentarian.

Through the Junior League, Kelley has volunteered with other community events and organizations, including the Humane Society and the Cultural Enrichment Fund.

Kaufman received her B.B.A. from The College of William & Mary in 2002, and her J.D. from the Wake Forest University School of Law in 2009.
