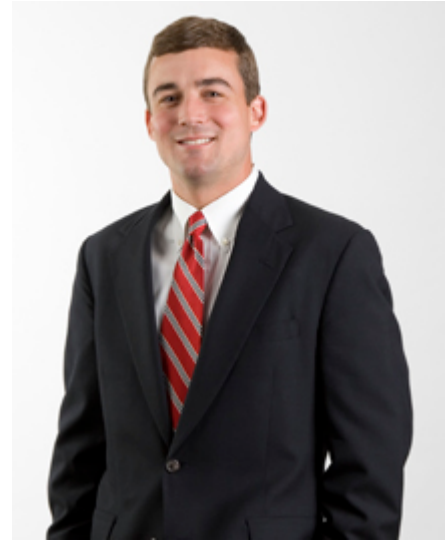


Will Johnson Receives the 2014 Leadership in Law Award

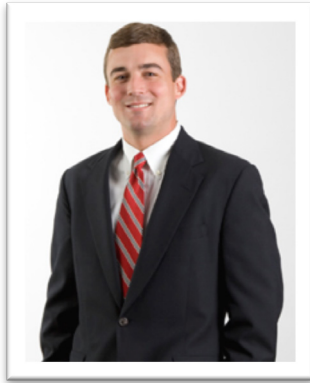
