The mock trial involved a fictitious case about a web advertising programmer who was fired by her employer, a production company for violation of social media policy. According to the fiction story line, the programmer took documents from work that she believed showed the company was secretly working for the government and creating propaganda that was being distributed through social media websites. After the documents were leaked, an internal investigation was commenced and the programmer was implicated. After she was confronted by the CEO of the production company, the programmer admitted her actions and was summarily terminated. The programmer sued, claiming wrongful termination and alleging sex discrimination at same company, specifically by CIO, with whom she also alleged having had a two year sexual relationship.

The mock trial involved unexpected twists and turns in the case and the attorneys' reactions to the surprises. "I thought the experience in litigating with lawyers across the country was a worthy challenge and for a good cause," Dan Santaniello, Managing Partner of Luks, Santaniello, Petrillo & Jones, said.
