



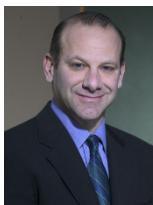

## RIKER DANZIG TO STAY IN MORRISTOWN UNTIL AT LEAST 2025

Morristown, NJ (August 18, 2015) – Morristown-based law firm Riker Danzig Scherer Hyland & Perretti LLP is pleased to announce that it has renewed its lease in Headquarters Plaza, committing to remain in the West Tower of that Morristown office complex until at least 2025. Riker Danzig has been in Morristown for over forty years and is a huge supporter of town activities, charities, and social events.

The lease, which provides for ±110,000 square feet at Headquarters Plaza, makes Riker Danzig the largest single office tenant in downtown Morristown. Morristown, and Headquarters Plaza specifically, was our first choice throughout the lease negotiations.”



Riker Danzig Managing Partner Glenn A. Clark noted that he has worked in Morristown for over 35 years. “It’s the only place that I have worked in my adult life, and it’s a fantastic place to work. I am very happy that we will be here for at least another ten years.”

Clark added, “We have grown significantly over the past 12 months and now need to reconfigure our offices to accommodate that growth here in Morristown. For example,
