The award is presented annually to an exemplary individual demonstrating strong commitment and determination in reducing auto theft-related crimes such as stolen vehicles, auto related insurance fraud and identity theft, chop shops, carjackings and the like throughout the state of Michigan. Ms. Scott also served as a 2013 Committee Member for H.E.A.T.

H.E.A.T. Director, Terri Miller, had this to say about Ms. Scott at the 28th Anniversary Breakfast held at Comerica Park in Detroit where the award was presented, "Margaret's professional and personal dedication – or shall I say, zeal - for the fight against auto theft and insurance fraud made her a prime candidate for this award. Founded in 1985, H.E.A.T. is a community education and prevention program dedicated to connecting citizen information with public law enforcement action to combat auto theft-related crimes in Michigan.
